



7. ONEIG AGM. Members reflected on the new format of the AGM, that is was well done given the limitations however some challenges in terms of communication and participation. Comments that AGM good blend of new technology with compassion and flexibility.

8. ONEIG water - resolution #2 debrief . Resolution passed with 97% approval from consultative representatives. Josalyn described the amendment process, that final wording of the resolution was strengthened in reference to rights based approach to water and integrating more wording about collaboration into the resolution.

Changes to languages to include partner leaders and ensuring that process in place to support public ownership of water resources. Overextraction a focus.


Discussion of process for resolution next steps with RNAO. RNAO Board meets to prioritize actions on resolutions. We will wait for RNAO to reach out for further direction and RNAO does report back at next AGM on actions taken on previous resolutions.

We talked about how we (ONEIG) own our resolution. In relation to next steps of the resolution, Kim described that actions taken by RNAO are strengthened by the continued participation of resolution submitters.

Sue provided an update to say that she was able to provide feedback regarding wording related to Bill 132. Will need to see if feedback used to change wording.



- 9. Environmental research resolution #3 debrief Hilda described that the resolution needed many changes through amendment discussion, such as the wording around "research" initiated by RNAO. The resolution was carried with over 70% voting in favour.
- 10. Membership survey and mobilizing members at large Josalyn described interest in communications campaign around water and pollution. An email distribution list is prepared for members interested in ad hoc volunteering.

- 13. Plastics webinar, next steps with recording Webinar went well, experience helped with confidence with the process, desire to do more of this.
- 14. Another webinar? Plan for a separate meeting to plan webinars over next few months. To discuss timelines, topics focus on water and plan for how recording to be used/shared.
- 15. The Story of Plastic special screening Discussion about the film from those who had a chance to see it, mixed feelings expressed about the piece, concern not focused enough on situation in north America and too long; other view strength of film is global focus. Plan for Elise to thank Story of Plastic team for the special screening permission.
- 16. ONEIG funds Discussion of different ideas to utilize funds to support mandate of ONEIG. Could to giveaway of Best Practice Guidelines, renewable/reusable items, books, picnic pack. Option for winner to be able to give away prize if not something they will use. Other option, paying for ONEIG members to attend events/courses related to environmental health/justice.
