- Political action regarding health care:
  - o The President shared the political action which he undertook in representing and speaking on behalf of our association in his meetings and media interviews.
  - o Paul-André met a few times with the MPP for Nickel Belt, France Gélinas, and for Sudbury, Jamie West. He has regular communication with them on Social Media since last February. His



last intervention was to remind the 2 MPPs - Charles McVety, president of Canada Christian College. "This latest move hasn't escaped the opposition at Queen's Park, with the NDP's anti-racism critic, Laura Mae Lindo, stating this week that the college has a "longstanding and ongoing record of Islamophobic, transphobic and homophobic bigotry." Which raises the question of why the government would have done all this in the first place."
