GET THE LEAD OUT! WATER CONVERSATIONS WITH CELA

By Rob Samulack On March 8th, ONEIG co-chair, Rob Samulack attended the Water Conversations zoom session put on by the Canadian Environmental Law Association. Lead bioaccumulates in living organisms and, in humans, can cause many negative health outcomes. There is no safe level of lead in municipal drinking water and efforts are being made to eliminate it entirely, however those efforts are piece-meal municipality by municipality. Health Canada guidelines call for a maximum of 5 mcg/L whereas Ontario guidelines still allow for 10 mcg/L. Older houses are worse off.

Many barriers exist fixing this problem. Often the municipality has responsibility for lead in the service line up to the property line, but it is the responsibility of the private property own<mark>er after</mark> that. Even if the property owner knows of the existence of lead, that information may not be passed on to the tenant. In some jurisdictions, when a tenant requests testing, the municipality may require the owner's consent. Some vulnerable sector institutions, like regulated daycare facilities and schools, have mandatory testing. There was talk of testing being a part of real estate disclosures at time of sale to encourage property owners to make changes, much like replacing a roof.

Municipalities like Ottawa for <u>free testing programs</u> and loan programs to assist with replacements. However, this is a health equity issue as renters or lower-income owners often do not have the permission or financial capacity to replace lead pipes.

Provincial regulation in line with Health Canada guidelines would be the best means of creating change, but this requires political will - something lacking in our current red-tape cutting, wetland-paving, gas plant building political climate provincially. A cost analysis comparing the cost of implementing the elimination of lead in drinking water to the cost burden to the healthcare and social services systems as well as loss of productivity will need to be made to fiscally-minded policymakers.

ONEIG Goes to Queen's Park 2023

This March, I represented ONEIG (in person!) to shake things up and advocate for health directly at Queen's Park. RNAO advocated together for the desperate need for action on the nursing staffing crisis (drawing on wisdom from the <u>Nursing Career Pathways</u> report) and the opioid crisis (including decriminalization, and equitable access to safe supply and injection services). I was joined by other members from my local area Waterloo Chapter and grateful for Kathy Moreland, who has really championed action on the opioid crisis anchored by both research evidence and personal experience.

As I mentioned in the winter newsletter, the most effective strategy for health system resilience is a robust and well-trained workforce. To reduce demand and preventable illness and death, we also need to act on some of the greatest threats to public health today: climate change and ecological degradation. This is why I used my question to Deputy Premier Sylvia Jones and Minister of Long-term Care Paul Calandra to ask whether the government will repeal Bill 23, the focus of an <u>RNAO action alert</u>. Minister Calandra directly stated 'no', citing the need for housing as the most pressing concern. Here is a short response I wish I had the opportunity to give:

FOSSIL FUELS THROUGH THE GREAT LAKES: LINE 5

On April 5th, I had the opportunity to learn about Line 5. On a panel moderated by Michelle Woodhouse, a Métis water defender and program director at Environmental Defence, Indigenous leaders highlighted serious concerns regarding the line 5 gas pipeline that runs through the Straits of Mackinac. They spoke about a legal battle launched by tribal nations and the state of Michigan in the United States against line 5, to force the decommissioning of the over fiftyyear-old pipeline, which has been the source of fossil fuel spills and crosses over a very sensitive area.

As quoted in a press release by Environmental Defence, Chairperson Austin Lowes of the Sault Ste. Marie Tribe Mackinac are central to the Anishinaabe creation story, which makes this location sacred from both a cultural and historical perspective in the formation of the Anishinaabe people. Protecting the Straits is also a matter of the utmost environmental and economic importance – both to our people and the state of Michigan."

Research and experts have demonstrated that a spill here would be catastrophic and a new report from Environmental Defence shows of Chippewa Indians stated: "The Straits of that there are alternative pathways to supply fuel to these areas. On the same day as this panel, leaders from tribal nations launched a press release about a recently filed complaint to the United Nations Human Rights Council regarding Canada's interference with their ability to protect their nations' lands, people, and culture. EARTH DAY: POLICY PERSPECTIVES WITH OLIVIA

As Earth Day approaches this year it is important for nurses to remain vigilant about pressing environmental policy issues that impact us as nurses and our patients.

THE GOVERNMENT OF ONTARIO IS LOOKING TO PASS BILL 71 BUILDING MORE MINES ACT. 2023. WITH THE LAST DAY FOR FOR PUBLIC COMMENT THROUGH THE ENVIRONMENTAL REGISTRY OF ONTARIO BEING APRIL 16. 2023. BILL 71 IS ADVERTISED AS PROVIDING AMENDMENTS TO THE MINING ACT THAT WOULD REMOVE ADMINISTRATIVE BURDENS & IMPROVE EFFICIENCY. AND WHAT IS THE TRADEOFF FOR THESE "IMPROVEMENTS"? BILL 71 IS EXPECTED TO: REDUCE THE PROTECTIONS FOR THE RIGHTS OF INDIGENOUS PEOPLE IN PROSPECTIVE MINING AREAS. REDUCE REQUIREMENTS FOR MINING COMPANIES TO POST BONDS FOR CLEAN-UP COSTS ONCE MINING ACTIVITY ENDS. LOWER STANDARDS FOR REHABILITATION MEASURES. ALLOW COMPANIES TO START OPERATIONS BEFORE HAVING COMPREHENSIVE CLOSER PLANS. AND ALLOW COMPANIES TO APPROVE THEIR OWN CLOSURE AND REHABILITATION PLANS WITHOUT GOVERNMENT APPROVAL.

WHY IS BILL 71 RELEVANT TO NURSING? SOME STUDIES SUGGEST THAT LIVING IN COMMUNITIES SURROUNDING ACTIVE MINES RAISES THE LIKELIHOOD OF CITIZENS DEVELOPING CANCER FROM THE EXPOSURE TO TOXIC SUBSTANCES (ALTHOUGH SPECIFIC CANCERS ARE RELATED TO DIFFERENT TYPES OF MATERIALS MINED). ABANDONED MINE DRAINAGE MAY RESULT IN POLLUTED WATER AND ADVERSELY IMPACT HUMAN LIFE. PLANT LIFE. AND WILDLIFE IF REHABILITATION MEASURES ARE LOWERED. THIS IN TURN IMPACTS FOOD CHAINS WHEN CROPS AND ANIMALS ARE POISONED BY EXPOSURE TO HEAVY METALS AND CAN RESULT IN LOCAL FOOD INSECURITY OR ECONOMIC STRIFE WHEN PRODUCTS CANNOT BE SOLD. CHILDREN RAISED IN MINING AREAS ARE OFTEN OBSERVED TO HAVE HIGHER LEVELS OF HEAVY METAL IN THEIR BODY WHICH CAN HAVE LONG-TERM NEUROLOGICAL CONSEQUENCES.

THE PEOPLE IMPACTED BY BILL 71 COULD BE YOUR PATIENTS. FROM AN ADVOCACY PERSPECTIVE, YOU CAN SIGN A PETITION OPPOSING THE AMENDMENTS TO THE MINING ACT. OR CONTACT YOUR LOCAL MPP TO DISCUSS THE ISSUE. FROM AN EDUCATION PERSPECTIVE YOU CAN READ MORE ON THE ISSUE TO INFORM YOURSELF. AND EDUCATE YOUR PATIENTS ON WHAT IMPACTS TO THEIR HEALTH MAY INCLUDE. FROM A TREATMENT PERSPECTIVE YOU CAN FAMILIARIZE YOURSELF WITH SIGNS AND SYMPTOMS OF CURRENT CONDITIONS THAT CAN ARISE IN COMMUNITIES NEAR MINES.

REMEMBER THAT ENVIRONMENTAL ACTION AND EDUCATION SHOULD NOT STOP ONCE EARTH DAY IS OVER!
