I represent FCNIG at RNAO meetings including RNAO assembly, RNAO annual general meeting (AGM), and Queen's Park Day, as well as in the public and the media. I serve you by disseminating information on educational events and resources to support your practice as parish nurses. In addition, I connected with Mary Lynne Knighten who is a Faith Community Nurse (FCN) and President-Elect of the Faith Community Nurses International (FCNI) based in the United States of America. FCNI has an online toolkit for FCNs which include resources on Advance Care Planning and End-Of-Life, Aging and Elder Care, Mental and Behaviour, Fall Risk Prevention, and many other resources valuable to FCNs. We look forward to partnering with FCNI in the provision of educational events for members of FCNIG and vice versa.

On January 28, 2023, FCNIG held an exciting and informative educational event where we had two talented speakers. Siobhan Carlin, an Advanced Care Paramedic and a trainer for The Working Mind First Responder and Applied Suicide Intervention Skills Training, presented on the topic, "What to do in an Emergency and a Review of the I.C.E (In Case of Emergency) sheet." Bob Parke, a Bioethics consultant, and an active member of the advisory committee to revise the federal governments Advance Care Planning framework, presented on Advance Care Planning.

We had a hybrid (online via Zoom and in-person) networking event during the RNAO Annual General Meeting on June 24, 2023. The meeting provided an opportunity to network with other parish nurses. Additionally, there was an opportunity to listen and participate in the presentation by Michelle Solomon, our very own FCNIG Communications Executive Network Officer (ENO), Michelle is the past founder and executive director of Connect for Mental Health, a not-for-profit organization that provided peer support to individuals affected by mental illness. Michelle presented her research on how youth living with bipolar disorder describe their understanding of and experiences of spirituality. This research aims to provide an awareness of the spiritual dimension in youth mental health and the importance of its integration in promoting wholistic well-being.

Good news, please join me in welcoming our new Student Laison ENO, Khalila Campbell-Fagan who is in her third year of the BScN program. The remaining positions (2-year term) that need to be filled are: Chair (President), Finance ENO, Membership ENO, Communications ENO, Social Media ENO, and Policy and Political Action ENO. Membership Report

By observing the graph for membership numbers over the past 6 years, one can see that overall, except for the total student membership, the other category shows that their total numbers do fluctuate yearly but general around 100 members. The total student membership relatively similar from last year (843 last year vs 723 this year). However, the total combined RN/NP membership has decreased significantly from 103 last year to 63 this year, a decrease of 40 members. We also have 10 retired nurses this year.

Since we do not charge students a membership fee, this initiative has resulted in the student membership rising so high.

Policy and Political Action Report

RNAO has 2 annual signature events for the Policy and Political Action Network. They are the 1) Queen's Park on the Road event that is intended to connect the chapters to their local MPPs where they can establish a relationship and an open conversation with one another. QPOR event occurs in the November - December period. The RNAO nurse interest groups are to connect with their chapters or regions without chapters. RNAO wants the Political Action Network ENOs to work together. If the chapter is unable to accommodate a delegate from an RNAO nurse interest group, the chapter can approve that the delegate from the nurse interest group can approach the MPP in his/her riding(s) separate from the chapter QPOR event. 2) Queen's Park Day is the second RNAO signature event. It is held at Queen's Park and begins with breakfast with the MPPs. It is a full day event coordinated by RNAO office. Nursing and health care issues are discussed with the political leaders of Ontario. Queen's Park Day happens in February.

I was not able to coordinate with the RNAO Sudbury Chapter delegates to meet with the MPPs of Sudbury Riding and Nickel Belt Riding for QPOR in November 2022 but as a member of the RNAO Sudbury chapter, I was able to observe the meeting by Zoom. I was able to attend Queen's Park Day as the FCNIG PPAN ENO in February 2023 by Zoom

I am excited about the recent invitation from the RNAO Algoma chapter. I attended the RNAO Sudbury Chapter AGM October 2023. The Sudbury Chapter declined my request to attend the 2023 QPOR event with them but approved my request to meet with the Sudbury Riding MPP and the Nickel Belt Riding MPP separately as the FCNIG PPAN ENO. This will be done in the time frame of QPOR (Nov 1-Dec 15/2023). On Oct 25, 2023, I had the opportunity to attend the Zoom RNAO Algoma Chapter Fall Tour and AGM- Voice your opinion. Northern Ontario has very specific and very acute needs related to toxic drug supplies, accidental opioid drug overdoses and related deaths, shortage of doctors, RNs NPs, and all related health care workers. Emergency rooms are closing and ORs are locked. Doctors are closing their private practices in favour of sports medicine and private clinics. The Algoma Chapter would like to present 3 resolutions to the RNAO AGM in June 2024 concerning health care and nursing shortage in Northern Ontario. We have agreed to collaborate and work together on these resolutions. The resolutions will include authorship and support from the Algoma Chapter, the FCNIG and the Indigenous Nurses and Allies Interest Group as well as from the Canadian Association for Parish Nursing Ministry. I have reviewed the CAPNM Core Competencies and Standards of Practice and will incorporate them into this resolution. In 2015-16 I led the committee of indigenous RNAO RNs and NPs to write and present a resolution on the Truth and Reconciliation recommendations from the Federal Commission Report We presented the recommendation at the RNAO AGM 2016. It passed unanimously.

A faith community/parish nurse promotes health, healing, and wholeness (CAPNM definition). RNAO influences, informs, advocates, connects, protects, and inspires. Change is brought

about through unity and action. I believe it is time for the RNAO FCNIG to "step out and step up" with other RNAO groups to speak on emerging issues and to influence healthy public policy.

Communication ENO Report

The Executive Network Officer (ENO) for Communications, helps to spread the word about our association and our colleagues in nursing. By engaging the media, social media, and other platforms we can promote our interest group events to ensure that our voices as Faith Community Nurses are heard - "Speaking out for Health, Speaking out for Parish Nursing."

I joined the Faith Community Nursing Interest group as Communication ENO in October of 2022 after Gloria Wiebe had served for several years. It was my interest in spiritual health and the sense of urgency needed to focus on the spiritual dimension in mental health care that propelled me to join the FCNIG. Thank you, Gloria, for mentoring me, showing me how dynamic the Faith Community Nursing Interest group is, and for sharing our history and plans to advance nursing policy and practice with integration of spiritual health. After witnessing how the FCNIG works, I can second that we truly work as a team. Being new to the role, I have witnessed how FCNIG stays current with the needs of the community and takes action to help and be present through prayer, advocacy at Queens Park, and showing up to provide spiritual care to individuals, families, and communities across the province.

Activities of 2023

October 2022, I joined FCNIG, and with advisement from the execs, created an information flyer on FCNIG, Faith Community Nursing education, CAPMN standards of practice, and the CNA position statement on spirituality. I connected with the senior academic counsellor at Western University (where I am completing a PhD in nursing on spirituality in youth and mental health) and sent this information to all the undergraduate nursing students informing them of the FCNIG interest group, membership opportunities, and the November 2022 AGM. I shared a database of post-secondary schools in Ontario to the Exec and planned to use this to recruit new members from nursing schools across Ontario.

November 18, 2022, Reached out to Anakul Thakur, web and social media editor at RNAO, to inquire about any special considerations and permissions needed before posting to FCNIG's social media; and to receive guidelines.

January 10, 2023, Met with Madison Scaini to discuss the Communication ENO role and topics I could address with the media.

January 28, 2023, Attended the Educational day in Toronto "What to do in an Emergency". How the pandemic has affected the delivery of emergency services, how nurses and health care providers have been impacted, and how Faith Community Nurses can disseminate all that we have learned to provide health services and spiritual care! I shared my first update on activities as Communication ENO.

January 30, 2023, Maria Lippa (social media ENO) and I met to create a plan to connect with FCNIG members and learn more about their needs as well as use social media platforms to share information about faith community nursing, FCNIG events and community faith-based events, news, and inspiration regarding what members were doing in spiritual care. Maria designed a "Pulse survey" to send out to FCNIG members to learn more about their needs including: if they were practicing as a nurse, how long they were practicing nursing, their areas of practice, if they worked as faith community nurses and in which communities, what they took away from FCNIG, what they would like to see more of, and areas of practice they wanted FCNIG to address.

February 6, 2023, Created Instagram, Facebook, and Twitter social media accounts for FCNIG. Created and shared a Google file with the executive members for us to be able to plan and contribute content to the social media posts.

February 9, 2023, Met with the communications officer/writer, Madison Scaini to go over the Communication ENO role. I learned about connecting with reporters, creating letters to the editor, and creating Op-Eds.

March 14, 2023 Sent mass email to members asking them to complete the "Pulse Survey" between March 17th and April 28th. Maria and I received the results at the beginning of May 2023 and the exec will plan to follow up on the results of the survey in the 2023-2024 term.

March 15, 2023, Mass email sent to FCNIG members regarding the Suffering & Spirituality: Workshop on clinical practices that promote healing in June.

March 19, 2023, Attended provincial communications ENO meeting with RNAO's communication team, Madison Scaini, Victoria Alarcon, and Marion Zych along with communication ENOs across the province to learn about the communication ENO role. Received FCNIG's profile picture for social media posts.

March 21, 2023, Posted FCNIG's first social media posts to Instagram and Facebook.

April 13, 2023, Initiated a meeting with the executive team to decide what type of information and events we wanted to share with FCNIG members and the public on social media, as well as to decide who would have access to the social media accounts and be responsible for posting events.

April 21, 2023, Updated the FCNIG website and added FCNIG's Twitter feed to the web page.

May 5, 2023, May Tao sent the spring newsletter out to members.

June 2, 2023, Mass email sent to FCNIG members regarding the June 24 networking event at the RNAO AGM.

June 22, 2023, Created Instagram and Facebook posts for Sanctuary Mental Health Ministries and The Porter's Gate's newest album.

June 24, 2023, Attended the networking event in Toronto. Was a key-note speaker sharing my preliminary PhD research findings, "A Picture of Spirituality in Youth Living with Bipolar Disorder" with FCNIG members. First public presentation of research findings.

August 28, 2023, Sent mass email to FCNIG regarding part-time position-Faith Community Nurse-Fall.

August 2023 - October 27th, 2023, Mass emails were sent to FCNIG members along with Instagram and Facebook posts regarding the following events:
