## **Purpose:**

We want to recognize locally registered nurses and nurse practitioners for their outstanding professional achievements. These awards acknowledge nurses who demonstrate actions that reflect the vision, mission and strategic direction of RNAO as well as model excellence in nursing practice in client care and the nursing profession.

**\*\* Note** *that the current President of the Sudbury and District Chapter of RNAO and the Nursing Week Committee members are not eligible for nomination.* **\*\***

## **Description of awards:**

- **The Nursing Practice Award**

The RNAO-Sudbury Award for Nursing Practice is awarded to a nurse (RN or NP) who consistently demonstrates nursing expertise in one or more areas of clinical practice in a staff nurse position. The award recipient exhibits effective teamwork and leadership within the nursing and health-care community. This nurse enhances the image of nursing by demonstrating nursing leadership in his/her workplace, as well as, influencing change for the betterment of residents/patients/clients, and families.

- **The Special Nursing Contribution to our Community Award**

The RNAO-Sudbury Award for Special Nursing Contribution to our Community is awarded to a nurse (RN or NP) who consistently demonstrates expertise in one or more areas of nursing practice within the community. The award recipient exhibits effective teamwork and leadership within the nursing and health-care community. This nurse enhances the image of nursing by demonstrating nursing leadership in his/her workplace and by influencing change for the betterment of patients/clients, families, and/or the community.

- **The Special Contribution to the Nursing Profession Award**

The RNAO-Sudbury Award for Special Contribution to the Nursing Profession is awarded to a nurse (RN or NP) who consistently demonstrates expertise in one or more areas of nursing practice. The nurse has made a significant contribution to the advancement of the nursing profession at the local and/or regional level(s). This award recipient enhances the image of nursing by demonstrating excellent nursing leadership in his/her workplace and by influencing change for the betterment of patients/clients, families, and/or community. This nurse acts as a resource for other nurses, and is a role model for professionalism.

- **The RN of the Year for the Sudbury Chapter Award**

The RNAO-Sudbury Award for the RN of the Year is awarded to a nurse (RN or NP) who consistently demonstrates expertise in one or more areas of nursing practice. The nurse will have shown outstanding leadership within organized nursing at local, regional, and /or provincial level(s). This award recipient enhances the image of nursing by demonstrating nursing leadership in his/her workplace and by influencing change for the betterment of patients/clients, families, and/or community. This nurse is an exemplary role model, a mentor to peers, and is a model of professionalism.

### **Eligibility Criteria:**

1. The candidate must be nominated by a Registered Nurse or a Nurse Practitioner.
2. The candidate must be an RN, an NP, or a retired nurse (RN/NP).
3. The candidate must reside within the Greater Sudbury area or the RNAO-Sudbury Chapter's designated catchment region.
4. The candidate may be preferably a current member of the RNAO-Sudbury Chapter.
5. The candidate must serve as a role model to nursing colleagues, for example, by:
  - a. Utilizing or demonstrating competencies in the domain of nursing practice.
  - b. Demonstrating quality care because of his/her practice.
  - c. Promoting change that impacts resident/ patient/ client care.
  - d. Encouraging collaboration to improve healthcare.
6. The candidate actively promotes the role of registered nurses or nurse practitioners.

**P.S.** If you have an **exceptional candidate** who is not a member of RNAO, **we will consider** the person for nomination depending on his or her contributions to the profession and the nursing practice in our catchment area.

### **Selection:**

Applications received by the deadline will undergo review by the selection committee. All candidate information must be received by the specified deadline date. The nominator of the successful candidate will be notified prior to notification of the winning candidate.

### **Instructions for the submissions:**

1. Complete the Nomination Form (page 1 of this package) with all the information required.
2. Append an attachment providing information that supports the candidate's eligibility to the specific criteria for the award.
3. Submit all nominations individually, if nominating more than one candidate.
4. Submit a separate statement of 300 words or less describing the nominee (**see the criteria above**); excerpts may be read at the time of reception when the award is presented or shared via RNAO Sudbury Chapter social media or newsletter.
5. Submit electronically all documents in Microsoft Word format.
6. Ensure that the nominee's name **does not** appear anywhere in the body of the material submitted. The nominee's name should **appear only** on the Nomination Form (page 1 of this package).
7. Submit one (1) letter of recommendation from another registered nurse or a nurse practitioner.
8. Note that selection is made based only on the information submitted.
9. Winners will be notified the week before the celebration and invited to attend the dinner.
